 - 2. Review the new Intake sheets, which follow.
 - 3. No 2D submissions will be accepted after the above Intake dates.
 - a. Check your inventory periodically in order to replace inventory.
 - 4. Bring only your signed signature page and the Intake pages listing anything entered in the Gallery that is not in the online show to your in-person Intake.

TERMS OF PARTICIPATION

PLEASE PRINT LEGIBLY

- 1. All art exhibited must be FOR SALE.
- 2. I warrant that the artworks, in whole or in part, are created solely by me and I warrant that the artwork, in whole or in part does not infringe on any copyright.
- 3. I will receive 75% and MAG will retain a 25% commission for works sold during the Gallery show.
 - a. The Guild will send your check the first week of the month following the sale unless the amount owed to you is less than \$20.
 - b. When the amount reaches \$20, a check will be sent to you the first week of the following quarter.
- 4. I will pay a 10% commission to MAG, within one month of the sale, for any sales of my work resulting from referrals from the gallery or contacts made through the gallery.
- 5. I will remove unsold 2D work from the gallery on the pickup date shown above.
 - a. 2D prints, greeting cards and all 3D work may remain in the Gallery for 2 shows provided the Intake Fee is paid for each show on or before the Intake date for each show.
 - b. At the end of the 2 shows, I will to adhere to the Pickup date listed above for the second show.
- 6. I will call MAG to make arrangements if it is not possible to retrieve my work on a Pickup date.
- 7. Work left 30 days past the Pickup date becomes the property of Mountain Artists Guild.
- 8. I am required to host one or two shifts in the gallery, serve on a volunteer committee, volunteer at a MAG festival or other special event, or pay a fee of \$40 in lieu of volunteering.
- 9. I will give advance notice if I cannot make my shift by calling (928) 776-4009.
- 10. If neither volunteering nor payment obligations is met during the current show, I will volunteer additional hours in the next show or pay an extra \$40.00.
- 11. Mountain Artists Guild will assume no liability for loss by theft, or damage to my work.
- 12. I release the Mountain Artists Guild, its staff, volunteers, and directors from any responsibility, personal liability or claims for loss or damage arising from my participation in an exhibit in the gallery.
- 13. I give MAG permission to use, in all its social media, digital and print publications.
 - a. Photographs of my art and art creations entered into MAG shows
 - b. My Biography and/or Artist Statement

FRAMED OR GALLERY WRAPPED ORIGINAL PAINTINGS OR PHOTOGRAPHS (LIMIT 3)

- 1. Members will have one signed painting or photograph accepted per show, and others, as space allows.
- 2. Identify all entries with your Artist Code, a unique entry number per item and price per item. Do not use an entry number more than once on the entire intake form.
- 3. Attach the label with description on the back of the item (see last page of this document).
- 4. No wet paintings will be accepted.
- 5. Frames, mats and glass must be in gallery condition.
- 6. Unframed paintings must be gallery wrapped, with the finished edge painted, with a minimum of 1" to canvas edge.
- 7. Current gallery standards are for framed oils, acrylics and watercolors to have a dustcover on the back.
- 8. For framed paintings/photographs, picture wire must be securely attached and strong enough to hold the work. It is recommended wire be attached to the frame 1/3rd of the way down the frame and must hang 1.5" minimum below the top of the frame. No sawtooth hardware is permitted on original paintings or photographs.
- 9. After one year, artists may resubmit pieces which have not won any MAG awards.

- No sawtooth hangers
- It is suggested that framed oils, watercolors and photographs have a dust cover
- No visible tape
- After one year, artists may resubmit pieces which have not won any MAG awards
- Paintings must be framed or if gallery wrapped, sides must be neatly painted (any color), and be 1"or more.

UNFRAMED PRINTS, SMALL ORIGINAL PAINTINGS, GREETING CARDS, JEWELRY, TOTE BAGS, POUCHES, SCULPTURE, POTTERY, JEWELRY, WOODWORKING ETC. ALL ITEMS MUST BE FOR SALE; NO "NFS" ITEMS.

- 1. Place tags or stickers on all works with Artist's Code, the item entry number and price (suggest Avery removable multi-use labels no smaller than 5/8 x 7/8")
- 2. The bottom of works such as stoneware, clay or porcelain must be smooth and have protective pads so that it will not scratch glass/wood surfaces. If 3D works need to be displayed standing, they should come with a base or other support for display. If work requires special installation on floor, ceiling or wall, or is especially large, contact the gallery first to determine if it can be accommodated.

JEWELRY:

- 3. Earrings must be on a card which is a minimum of 1 inch by 1.5 inches; limit 25 pairs.
- 4. Necklaces, bracelets, and sets, etc. must have a hang tag attached to each piece at least 1 inch by 1.5 inches in size; limit 25.
- 5. Do not use any entry number more than once on the entire intake form.
- 6. Prints and cards must be in plastic sleeves; limit 25 prints and 25 cards.
