- If 3D works need to be displayed standing, they should come with a base or support for display. If work requires special installation on floor or ceiling, contact the Guild first at (928) 445 2510 to determine if it can be accommodated.
- Earrings must be on a card no smaller than 1" x 1.5" and will be limited to 25 pairs per artist
- Necklaces, bracelets, sets, ornaments, etc. must have a hang tag attached to each piece no smaller than 1" x 1.5" and will be limited to no more than 25 such items per artist.
- Prints and cards must be in plastic sleeves
- Artists will be limited to no more than 25 of each category of item. Like-items that have the same price should be grouped into one entry number. (see below)
